

An Appeal may be submitted to the Minister of Education [Section 124 of the School Act] (See Table 1 for the topics of appeal suitable for this level of communication)

Table 1: Items for Appeal to the Minister S. 124 of the *School Act*

- Placement of a student in a special education program
- Right to instruction in French (Section 23)
- Home Education Program
- Expulsion of a Student
- Amount and payment of fees or costs
- Access to, or the accuracy or completeness of student records
- Amount of fees payable by a Board to another Board
- Which Board has responsibility for a student



Table 2: Communication Protocol

Decisions made at any administrative level are subject to review to the next level of administration if the matter significantly affects the education or safety of the student.

- e. Superintendent, 780-674-8525
- f. Board per <u>Policy 200-3 Appeals to the Board Regarding Student Matters</u> if the matter significantly affects the education of the student
